For a modification to be approved, the project Sponsor or Owner must have made reasonable efforts to meet the original commitments or must provide a reasonable written justification of why the commitments cannot be met. There must also be a good cause for the change, as determined by the Bank at its sole discretion. Examples of a good cause include events outside of the sponsor's control and changes necessary for a project to maintain feasibility such as: 1) a change in market conditions; 2) loss of committed funding to subsidize project rents; or 3) loss of a major employer in the community that makes it difficult to find households at the incomes committed to in the project's AHP application to occupy the targeted units in the project.
